- 4. Under no conditions will the manufacturer be responsible for labour charges, cost of loss of water or chemicals, or any other related damages that may occur.
- 5. Any and all freight charges for any liner returned for repair or replacement must be paid by the owner.

MANUFACTURER warrants to the original purchaser that each Winter Vinyl Cover is warranted in the following manner: THE MANUFACTURER warrants the Winter Vinyl Cover against damage due to faulty workmanship or defective manufacture for a period of five years pro rated at a 20% declining yearly scale based on the current MANUFACTURER'S suggested retail price as long as the original purchaser owns the cover. If MANUFACTURER'S inspection confirms a claimed defect, MANUFACTURER agrees to replace or repair at its' option any portion of the Winter Vinyl Cover which has been defectively manufactured.

This warranty is subject to the following condition:

Any and all freight charges for any Winter Vinyl Cover returned to us for replacement or repair must be paid for by the owner. Any vinyl cover replaced or repaired by us shall be re-installed by you and at your own cost. MANUFACTURER shall not be responsible for any damage or defect to the Winter Vinyl Cover, which results from incorrect installation procedures, fire, floods, acts of God, from an act or acts of others and we shall have no liability to replace or repair any cover that is so damaged. This warranty is in lieu of all other expressed or implied warranties of Deys Fabricating Limited and the Selling Dealer, including any implied warranty or merchandising or fitness for particular purpose, neither Deys Fabricating Limited or the dealer assumes or authorizes any person to assume, on its behalf, any other obligation or liability.
